## About St Peter's Hospice

We're the only adult hospice covering Bristol, North Somerset, South Gloucestershire and parts of Bath and North East Somerset, an area of almost 1 million people! We offer those living with a terminal illness the highest quality of care, helping them make the absolute most of the time they have left. We help people adjust to life with an illness within their homes, we run a Day Hospice where patients can be around others in the same situation as them, forging support networks. We support patients at the end of life, either at home or in the Hospice, endeavouring to care for them in the environment they choose, and we offer bereavement counselling to loved ones.



A regular monthly donation from your salary will help us to continue this crucial work, providing the best possible palliative care to patients and their families.

## How Payroll Giving works

You give directly from your salary before tax is deducted, meaning the tax you would have paid goes to us. For example, if you're a basic rate tax payer, a pledge of £10 a month will actually only cost you £8.

You can give as much as you like and can change your donation at any time by just informing your payroll department.

## How to sign up

Firstly, ask your payroll department if your company is signed up to the scheme. If not, it's really easy to do. Either direct them to the factsheet for employers we have on our website: ([stpetershospice.org/payrollgiving](http://stpetershospice.org/payrollgiving)) or the Payroll Giving page on the government website: [gov.uk/payroll-giving](http://gov.uk/payroll-giving).

Once that's done you just need to fill in the attached form and give it to your payroll department. It's as easy as that!

## The benefits

- **It's really flexible.** You can change what you give and stop or freeze payments whenever you want.
- **It requires no upkeep.** Once it's set up, Payroll Giving requires no maintenance from you.
- **Your employer might double it.** Some companies offer matched giving on your payroll giving, making even more of your donation. No harm in asking!
